**Treasurer's Report**

**Adopt Resolution 21-07-27**

Shawn Jackson moved and Kim Owens seconded that the Board of Education adopt Resolution 21-07-27 as presented:

**RESOLUTION SUBMITTING TO THE ELECTORS OF THE SOUTHEASTERN LOCAL SCHOOL DISTRICT THE QUESTION OF THE RENEWAL OF AN EXISTING TAX LEVY FOR THE PURPOSE OF AVOIDING AND OPERATING DEFICIT OF THE SCHOOL DISTRICT**

The Board of Education of the Southeastern Local School District ("Board"), Counties of Clark and Greene, Ohio, met in special session on July 27, 2021, commencing at 2:00 p.m., with the following members present:

Shawn Jackson moved for the adoption of the following Resolution:

**SOUTHEASTERN LOCAL SCHOOLS**

**RESOLUTION NO. 21-07-27**

WHEREAS, on July 20, 2021, this Board adopted Resolution No. 21-07-20 declaring it necessary to renew a tax levy for the purpose of providing for the current operating expenses of the school district in order to avoid an operating deficit, for five years and requesting that the Clark County Auditor certify the total current tax valuation of the District and the calculation of the annual levy, expressed in dollars and cents for each one hundred dollars of valuation as well as in mills for each one dollar of valuation, throughout the life of the levy which will be required to produce the annual amount of four hundred ninety thousand dollars (\$490,000); and

WHEREAS, on July 23, 2021, the Clark County Auditor certified that the total tax valuation of the District is One Hundred Thirty-Two Million, Nine Hundred Eight Thousand and Four Hundred Seventeen Dollars (\$132,908,417) and the estimated property tax revenue that will be generated by the renewal of the existing emergency tax levy, assuming the tax valuation of the subdivision remains constant throughout the life of the levy, is calculated to be three and sixty-nine hundredths (3.69) mills for each one dollar (\$1) of tax valuation, which is 36.90 cents (\$.369) for each one hundred dollars (\$100) of tax valuation;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education of the Southeastern Local School District, Counties of Clark and Greene, Ohio, two-thirds of all members elected thereto concurring, that:

1. The amount of taxes which may be raised within the ten-mill limitation by levies on the current tax duplicate will be insufficient to provide for the current operating expenses of the Southeastern Local School District in order to avoid an operating deficit and it is necessary to
